- All 5 HIAs low income, high communities of color
- 4 focused on informing planning process
- 1 influenced decision of location of regional recreation center



South Lincoln Redevelopment Case Study

- South Lincoln Homes owned and managed by Denver Housing Authority
- 270 Public Housing units on 15 acre; majority Hispanic
- Redevelop site: mix of housing products; range of income levels; triple population; TOD; 1:1
- Identified indicators Healthy Development Measurement Tool

Phases: Scoping Health Impacts to Consider

Data Collection/Community Engagement

- 3. Comparative data from Denver communities
- 4. Data from departments i.e. police
- 5. Healthy Development Measurement Tool indicators
- 6. Other HIAs
- 7. Interviews and focus groups with agency staff, community members i.e. senior group

Initial Findings: 61 total recommendations

More Feasible	27	44%	27	100%
Less/Not Feasible	34	56%	10	29.4%

Recommendation – Parking

- Back-in angle parking provides safety benefits for lower speed roads such as 10th street promenade and 11th in front of the recreation center but currently city regulations do not allow for this type of parking.
- On the north side of 11th Avenue between Osage and Mariposa Streets: back-in angled parking adjacent to Lincoln Park.
- Not Feasible Total adoption

One Outcome

- City Councilwoman became advocate for use of HIAs. She promotes health throughout city departments. Held meetings with Denver planners, state and city health staff, about incorporating HIAs into plans throughout Denver.
- Public health considerations is now included within request for proposals (RFP) for CPD and DHA.
