# IT MATTERS WHERE YOU LIVE



In the November 2004 general elections, 74% of **Oregon's** eligible voters went to the polls — the third-highest participation rate in the country. **Oklahoma's** rate — 62.3% — ranked 37th in the nation.




Wyoming ranks 1st in federal aid to state and local governments (about \$3,918 per capita); Virginia ranks 49th (about \$942 per capita).



**South Dakota** ranks 23rd in percentage of population with a high school diploma (87.5%); **Minnesota** ranks 1st (92.3%).



**Nevada** ranks 2nd highest in release of toxic chemicals. **California** ranks 46th.

Tennessee's foreignborn population increased by about 36% between 2000 and 2004. New York state's foreign-born population grew by just roughly 3% during the same period.



In **Minnesota**, over 90% of non-elderly residents have health insurance. That's the highest rate in the nation. **Texas** has the lowest rate: 72.4% of its non-elderly residents are insured.



Massachusetts spends the most per prisoner: \$80,238 per year. Mississippi, at \$10,094 per year, spends the least.



Between 2000 and 2005, home prices in **Rhode Island** rose by more than 100%. During the same period, **Utah's** home prices increased 21.75%.



Voluntary preschool is free to all 4 year olds in **Georgia**; **Indiana** does not offer state-funded preschool.

State policy makers spend far less time in the limelight than members of Congress. Yet their decisions on a range of critical issues — from education reform and health care to homeland security and the environment — deeply affect the lives of all Americans. State lawmakers are often more willing than their federal counterparts to cross party lines and take risks to develop innovative solutions to difficult problems. Many state decision-makers are tackling important issues by forging common ground and looking across their borders to see how other states are managing similar challenges.



# The Pew Center on the States advances effective policy

States advances effective policy approaches to critical issues facing states. The Center conducts nonpartisan research, brings together diverse perspectives, analyzes states' experiences to determine what works and what does not and collaborates with other funders and organizations to encourage nonpartisan, pragmatic solutions.



# THE CENTER'S APPROACH

#### **GATHERING INFORMATION**

The Center gathers data across states on factors that affect policy, from budget and economic trends to states' policy climates. This baseline research helps states, the Trusts and its partners better understand a range of potential state policy issues that affects the public. It also is used to generate a series of Webbased indicators and reports that highlight—and in some cases, grade—variation across states in areas of key concern to policy makers and the public.

#### **GUIDING INNOVATION**

As problems become serious, states begin to explore policy options, tackling issues in different ways. The Center identifies

challenges affecting multiple states and places where innovation is emerging. Using various tools—from research to meetings that bring diverse stakeholders together—the Center highlights the different policy directions in play in the states, assesses their impact and identifies approaches that have been most effective.

#### **ADVANCING POLICY SOLUTIONS**

We start with the facts—but we do not stop there. When solid evidence indicates that a policy approach is both effective and feasible, the Center enhances public education and advocacy efforts funded by the Trusts and others to help states move change forward.

#### AMONG THE TRUSTS' CURRENT STATE-FOCUSED EFFORTS

#### **EARLY EDUCATION**

The Trusts has invested more than \$48 million since 2001 to create the research base and informed debate that foster policies providing access to high-quality, voluntary early education for all three- and four-year-olds in America. Our partners work nationally and in more than a dozen states to encourage support for preschool for all. Two major organizations operate at the core of our work: The National Institute for Early Education Research and Pre-K Now. www.nieer.org; www.preknow.org

#### K-12 EDUCATION

Since 1994, the Trusts has supported *Quality Counts*, an annual report card published in *Education Week* that grades all 50 states on K-12 educational standards and accountability, efforts to improve teacher quality, school climate and resource equity. www.edweek.org

#### **ELECTION REFORM**

Electionline.org informs the public, federal, state and local policy makers and election officials on trends, important issues and best practices in election reform. Electionline.org tracks and analyzes states' progress in implementing the Help America Vote Act, a bipartisan federal law. www.electionline.org

#### CAMPAIGN FINANCE REFORM

The Trusts has been involved in a range of work to build a credible and effective campaign finance system to increase citizens' confidence and engagement in the electoral process. At the state level, the Trusts supports research and analysis of state campaign finance policies that seek to enhance competitiveness and expand the role of small donors in campaigns. www.pewtrusts.org

#### DEATH PENALTY REFORM

The Justice Project Education Fund educates the public and policy makers about the need for reforms to ensure fairness and accuracy in states' administration of capital punishment. Key reforms include DNA testing, adequate legal representation and procedural safeguards, such as rules governing police interrogations. www.pewtrusts.org

#### GOVERNMENT PERFORMANCE

The Government Performance Project seeks to help states improve how they manage their money, people, information and infrastructure — areas critical to converting sound public policy into practice. Its next 50-state report card will be published in February 2008 in *Governing* magazine. www.pewtrusts.org.

#### Public Safety And Corrections

This initiative supports research and public and policy maker education to help states make data-driven decisions in sentencing and corrections policy that increase public safety, reduce spending and hold offenders accountable. www.pewtrusts.org

#### FOSTER CARE

As part of its national foster care initiative, the Trusts supports activities to promote the recommendations by the Pew Commission on Children in Foster Care calling for judicial leadership and improved state court oversight of children in foster care. www.pewfostercare.org

State and regional programs can begin reducing emissions, serve as models for federal policy, and build critical support among policy makers, opinion leaders and the public for action.
