A. Overview

The mission of the Sioux Falls School District is "to educate and prepare each student to succeed in a changing world." To accomplish that mission, each department within the District has been charged to save tax dollars wherever possible in order to optimize funding for educational programs. To that end the Finance Office of the Sioux Falls School District is always researching ways to cut costs, increase efficiency, and use technology whenever possible.

School Board members are elected to three year terms. The terms are staggered so one member's term was finished in 2011, two members' terms are finished in 2012, and two members' terms are finished in 2013. The School District holds an election every year. Over the past six years, the Finance Office has been exploring ways to reduce costs for School Board elections.

In 2007, the District implemented the use of "super" precincts, which combined three or more precincts to reduce the total from 59 to 22. Each precinct must be staffed with between three and seven polling officials, depending on anticipated turnout at each polling place. Each official is paid over \$100. Some polling places charged rent. The rationale for the use of "super precincts" was that it made no sense to staff an election with a turnout between three and 40 percent – depending on whether there was a City election held in conjunction (even years) the same way the county staffed the general election (with a typical turnout in excess of 75 percent). Obviously, the more polling places and officials used the higher the costs for elections. The frequent changes in polling places between the various city, county and school elections meant some voters were confused at the next election that used all 59 polling places because they had voted at a different location the time before.

"Super" precincts reduced costs from the 2006 election by 48 percent (\$43,000 in 2006 to \$22,700 in 2007.) The District used "super" precincts for its election again in 2009 with a total cost for that election of nearly \$19,000. Voter confusion was the biggest downfall of "super" precincts.

The Finance Office continued to research how other jurisdictions in other states conduct their elections in an effort to reduce costs, eliminate voter confusion, reduce time standing in lines waiting to check in, and increase efficiency for poll workers and election administrators. Larimar County, Colorado, Tippecanoe County, Illinois, Cass County, North Dakota and Dallas, Texas have successfully used vote centers and electronic pollbooks to conduct their elections, including general elections.

In March 2010, the School District sent Finance Office staff to observe a Fargo, North Dakota election using Vote Centers and electronic pollbooks; the system was very efficient. Based on that, the 2010 Legislature passed permissive legislation to allow school districts with an average daily

membership over 20,000 to conduct their 2011 elections using Vote Centers and electronic pollbooks. The District was pleased to conduct the first election in South Dakota to use electronic pollbooks and Vote Centers on May 24, 2011. The following is the required report to the Secretary of State and the South Dakota Legislature.

B. Vote Centers

Vote Centers are much larger than regular polling places. A regular polling place typically has three to five workers, one paper registration book and five to eight voting booths. A Vote Center typically has five to nine workers, electronic pollbooks (all connected via an inter or intranet to every other Vote Center) and 15 to 30 voting booths, all depending on the expected turnout.

Using Vote Centers allows voters to choose where they vote. Nationally, voter participation in local elections has been declining for the past ten years. Certain jurisdictions, such as Larimar County, Colorado; Dallas, Texas; Fargo, North Dakota; Tippecanoe County, Illinois have seen voter turnout increase when using Vote Centers. By using Vote Centers, no registered voter in the jurisdiction is ever told to go to a different polling place to vote. Every Vote Center is the right place to vote.

Vote Centers save taxpayer dollars. Under the precinct system, the School District would necessarily staff each precinct with three to five workers whether 30 voters cast ballots or 2,000 voters cast ballots in a precinct. Vote Centers used between five and nine workers, depending on the anticipated turnout in a particular Vote Center. It is obviously much more efficient to staff ten Vote Centers with five to nine election workers than it is to staff 59 precincts with three to five election workers.

Vote Centers are typically located in well-known, easily found locations within the jurisdiction. The School District used only its own school buildings thereby eliminating the costs associated with rent. Using the precinct system, in some instances, the precinct location would charge rent of \$50 to \$125 per location.

C. Electronic Pollbooks

An electronic pollbook gives election officials real-time electronic access to voter registration information through an encrypted secure intranet or internet, regardless of the physical location of the Vote Center.

The Secretary of State's Office purchased the software licenses, scanners, signature pads, and printers from Election Systems and Software (ES&S) using Help America Vote Act funds in the amount of \$31,725. Patrick Henry Middle School loaned its mobile lab of laptops to the Finance Office for the May 24, 2011 election. The Finance Office purchased mice for the 22 laptops (\$103.35) to assist election officials. The Finance Office also purchased

training hours and support from Election Systems and Software in the amount of \$4,575.

The District provided a secure server for the election and the election software was loaded on 22 laptops. After close of voter registration on May 9, 2011, the Secretary of State's Office, assisted by the Minnehaha and Lincoln County Auditors, provided a database of voters for the School District's election.

D. The Sioux Falls School District Election

The District held its election for one seat on the School Board on May 24, 2011, using ten Vote Centers throughout the School District. The Vote Centers were located, as follows:

- 1. J.F. Kennedy Elementary School 4501 S. Holbrook Avenue
- 2. Memorial Middle School 1401 S. Sertoma Avenue
- 3. Hayward Elementary School 400 N. Valley View Road
- 4. Garfield Elementary 2421 W. 15th Street
- 5. Hawthorne Elementary School 601 N. Spring Avenue
- 6. Whittier Middle School 930 E. 6th Street
- 7. Anne Sullivan Elementary School 3701 E. 3rd Street
- 8. Harvey Dunn Elementary School 2400 S. Bahnson Avenue
- 9. Lincoln High School 2900 S. Cliff Avenue
- 10. Edison Middle School 2101 S. West Avenue

School was no longer in session which freed up the gymnasiums and the multi-purpose rooms for use by Finance Office to conduct the election.

While in Fargo, staff from the Finance Office noted that Fargo had table-top voting booths constructed of plywood, which when disassembled, were stored behind the vending machines in the Vote Centers. The students of the Career and Technical Education Academy's Carpentry Class constructed table-top voting booths for the District's election. They are easily assembled on top of a six foot folding table and allow six people to vote comfortably at one time with complete privacy. The table-top voting booths can be easily stored after each election and do not take up as much room as regular voting booths in suitcases. The table-top booths were made necessary due the expedited check-in process associated with the electronic poll books. The District also made regular voting booths available as well as the AutoMARK ballot marking system, which the District, in conjunction with the City of Sioux Falls, successfully piloted for the State of South Dakota in 2006.

The election administrative team consisted of: Jason Gant, Secretary of State Aaron Lorenzen, Director of Elections Bob Litz, Minnehaha County Auditor Heather Irwin, Minnehaha Elections Technician Randy Bauld, Sioux Falls School District Computer Specialist Bev Chase, Sioux Falls School District Elections Services

The election administrative team met with trainers from ES&S several times between January and May defining what the District's needs were for this election and how the software/hardware could be used in future elections.

The administrative team was trained on the electronic pollbooks May 5, 2011 and received training on computer/server requirements, connectivity, and synchronization May 9, 2011.

May 16, 2011, Finance Office staff met with the District's building computer specialists to train them on the software and election duties, which included setting up the electronic pollbook on Election Day. The computer specialists also were on call all day Election Day for troubleshooting and technical support for the election officials. The need to have computer-savvy technical support is imperative for the Vote Center concept to work. A computer specialist was involved in the process from the conception of Vote Centers in the Sioux Falls School District.

Election Officials who worked on Election Day at the Vote Centers attended mandatory training sessions that were held on different days and times during the week of May 16 through May 20, 2011. Each official received "hands on" training from the opening to the close of polls in conjunction with their normal Election School. Members of the election administrative team were on hand to help with the Election Schools. The officials came into the training room with some trepidation, but left fully prepared to handle their duties on Election Day.

Technical support staff from ES&S was on hand May 23 - May 25, 2011 for assistance. May 23rd was spent checking connectivity between Vote Centers and no issues were found.

On May 24th, Election Day, ES&S staff spent the day monitoring computer reports and helping to troubleshoot at Vote Centers. The computer reports gave up to the minute turnout reports. Officials could see, at the click of a mouse, which Vote Centers were the most used by voters.

At the polls the voter saw very little change in procedures:

- The voter came before the Election Official and stated his/her name.
- The voter handed his/her driver's license to the Election Official or displayed another one of the approved forms of identification or signed an affidavit of identification.

- If the voter handed the driver's license to the Election Official the driver's license was scanned. If the data in the barcode could be read, the voter information appeared on the Election Official's computer screen in three to five seconds. If the data in the barcode could not be read or if another form of identification was used or an affidavit was signed, the Election Official keyed in the last name and the first digit of the first name. The Election Official then selected the correct voter from the list of names on the screen.
- After the Election Official verified the information, the voter was asked to sign his/her name on the electronic signature pad, the signature also appeared on the Election Official's screen.
- The Election Official accepted the signature and a ballot receipt was printed.
 - ✓ (NOTE: The ballot receipt took the place of the poll list that voters sign in typical elections. In this election, the ballot receipt had no other purpose. In an election where there is more than one style of ballot (e.g. the June Primary - democrat and republican ballot), the ballot receipt would also indicate which ballot the voter would receive.
- The voter took the ballot receipt to the ballot clerk and received their ballot, ballot sleeve and pencil. The voter was directed to a voting booth. The voter cast their ballot and placed it in the ballot box.

The Sioux Falls School District did show an increase in voter turnout over its last stand alone election (2009) from an all time low of 3.55% to 4.27%. Although the turnout was still very low, it was improved.

The electronic pollbook performed exactly as anticipated. Officials knew going into this election that the South Dakota voter registration database would need "cleaning up" and not all licenses would be able to be scanned. However, the voter information for the District was easily accessed when the license would not scan.

On more than one occasion, Finance Office staff asked the Vote Center officials, at different Vote Centers, to call up certain individuals "just to see if they had voted", knowing full well that the individual had already cast a ballot. In all instances, the pollbook came up with the information that the voter was "DONE." Here again, the electronic pollbook performed exactly as anticipated and would not allow a voter to cast more than one ballot.

Absentee balloting is allowed by law on Election Day until 3:00 p.m. The Absentee Precinct's pollbook was also connected to every other electronic pollbook, so every Vote Center would have the information if a voter voted

"Absentee" and then tried to vote at a Vote Center. This is an improvement over previous elections in Sioux Falls and throughout the State.

The Vote Center concept is new to South Dakota, so Finance Office staff provided a survey for voters to voluntarily complete. Sioux Falls voters overall were receptive to the concept that would allow them to vote anywhere in the School District based on the responses and comments that were received.

Lincoln High School processed the most voters for the day (1,088) and Hayward Elementary School processed the least (104). Each Vote Center, except Hayward Elementary School, had two or more electronic pollbooks. The Vote Centers with the highest anticipated turnout had three electronic pollbooks and Hayward Elementary School Vote Center had one electronic pollbook.

It was very interesting that voter turnout shifted when voters had a choice of where to vote. Harvey Dunn Elementary and Memorial Middle School are usually two of the highest turnout voting areas—but Lincoln High School edged both of them out, with Harvey Dunn Elementary coming in second and Edison Middle School coming in third. One of the bonuses of using Vote Centers would be, if the jurisdiction had enough licenses, more pollbooks could be brought to busy Vote Centers. Lincoln High School concluded Election Day with a line of voters waiting to check-in. If the District had more than 22 software licenses to utilize, more pollbooks could have been delivered to Lincoln High School to speed up voter processing.

As stated earlier, on Election Day, the Vote Center officials handed out a simple survey card asking for voter feedback. Of the 4,090 voters who voted, 2,823 completed survey cards. A summary of the survey cards is, as follows:

The voters were also asked to give written comments if they wanted to which nearly 900 voters did:

- ▶ 557 comments were positive
- ▶ 161 comments were negative
- ▶ 159 comments were neutral

Overall, the voters approved of the use of Vote Centers and believed the electronic pollbooks sped up the check-in process. Going forward, if the School District was allowed to continue to use the ten Vote Centers, voters would become more familiar with the Vote Centers and ease of finding the centers, parking and doors would be improved. With the use of the electronic pollbooks, Vote Center officials would become more adept at operating the system and check-in would be even faster.

E. Cost Comparisons

The Sioux Falls School District holds an election every year. During even numbered years, the District combines with the City of Sioux Falls Municipal Election. In 2010 the District and the City of Sioux Falls held a joint election in April. This election was for school board members, a new mayor and council members, and also contained city charter amendments. The election was conducted at 59 precincts and 262 Election Officials were employed.

The 2010 election costs were split between the City of Sioux Falls and the Sioux Falls School District. The total cost of the election is shown in the chart below.

Several expenditures that were incurred for the 2010 election were not incurred in 2011. There was no need to hire the assistant polling place liaison. The AutoMarks, along with the voting booths, were picked up and delivered as a part of the normal delivery process of the School District because all of the Vote Centers were school buildings. There was no rent for polling places as only District buildings were used.

Several of the expenditures were greatly reduced from the 2010 election as well.

- The polling place liaison was only employed three days instead of three weeks.
- Mileage was greatly reduced with ten sites as opposed to 59 sites.
- Supplies and printed materials for use at the Vote Centers were reduced significantly from \$1,282.52 to \$677.86
- The biggest reduction was the cost for Vote Center Officials which was reduced by 190 workers. In 2010 the 262 Officials cost \$27,730.84 which included use of the Officials' cell phones (in some precincts) and mileage to the Official who drove the ballot box to the Minnehaha County Administration Building. This is compared in 2011 to 72 Vote Center Officials at a cost of \$8,900.40 which also included the use of cell phones and mileage. The 2011 costs for Officials also includes an increase of \$5 per official (\$360) because of the expanded skill set required for using a computer.

A few expenditures were added costs for the 2011 election. The table-top voting booths, "I Voted Today" stickers, and programming/training costs for ES&S were all new for 2011. The table-top voting booths were made by the students in the Carpentry Program at the Career & Tech Ed Academy for material cost only—labor was free. The 9,000 stickers were generic and can be used at any election; the cost was \$61.85; less than one penny each for publicity on Election Day. Programming and training costs were an essential piece when using the electronic pollbooks. There was an additional cost for overtime due to employing computer techs before/after normal business hours.

For the 2009 School Board election, the District used 22 "super precincts" which cost \$18,217.61. It is interesting to note that when the costs for the table top voting booths (which will be used for future elections), the costs for the "I Voted" stickers, the raise of \$5 per election official and the costs of ES & S training are removed, the 2011 election was just over \$200 more than when using "super precincts." However, "super precincts" were not popular with the voters and led to voter confusion as to polling place location during subsequent elections. There was no voter confusion in 2011 when using Vote Centers, because every Vote Center was the right place to vote.

F. Conclusions:

May 25th, the election administrative team met in the Minnehaha County Auditor's Office to discuss where the pilot hit the mark and where it was missed. Members of the Secretary of State's Office were on-site at all of the Vote Centers throughout Election Day. Several others were also present at the Election Recap Meeting. Alexia Scott-Morrison and Chris Grabow from Election Systems & Software were present to give feedback. The Minnehaha County Auditor and the Minnehaha County Election Technician were present along with members of the Sioux Falls School District Finance Office.

The conclusion drawn by the team was that the process worked well. Voter turnout had increased over the previous stand-alone election. The electronic pollbook performed as anticipated. The few glitches that happened were because of human error and not the technology.

Staff from ES & S showed the administration all of the reports that can be run following an election (see Appendix C.) The reports can show a summary of the number of voters at each location, a report of all of the names of voters who didn't vote, a report of the all the names of voters who did vote, and a provisional ballot report. In some states, changes can be made to the voter registration file and there are reports that can be run to show those changes; however, the School District, the auditors, and the Secretary of State did not want to allow any changes to the voter registration file so this capability of the system was blocked to Vote Center Election Officials.

Other Cost Benefits

Some costs cannot be measured in dollar and cents but in staff time on election-related tasks:

Following the election, Minnehaha County and Lincoln County will be able to upload the voter history data. Minnehaha County typically spends weeks after an election keying in data from the paper registration books. Using electronic pollbooks, once the information is uploaded to the counties' database, it can easily be transferred to the Secretary of State's database. One task that took weeks now will be done in less than a day.

Minnehaha County and Lincoln County auditors did not have to print and label voter registration books for the School District for its 2011 election saving staff time and supply costs for more than a box of green-bar paper which cost approximately \$60.

Sioux Falls School District personnel spent fewer hours compiling supplies for ten supply cases instead of 59. Fewer hours were spent creating, copying, and collating documents for ten forms folders. Fewer hours were spent finding replacement election officials because there was a larger pool to draw from (72 vs. 262). Less time was spent creating notices of appointment, worker reminder forms, and making phone calls to election officials checking information.

The District also realized a cost savings when printing School Board minutes in the official newspaper, as required by law, due to less voting locations and election officials included in the notice of election (see minutes of 5/9/11.)

G. Recommendations

The 2011 Sioux Falls School District Election successfully piloted electronic pollbooks and the Vote Center concept. Two recommendations would be:

1. In order to better serve <u>all</u> the voters of Sioux Falls, the electronic pollbook should be held on a secured, encrypted <u>internet</u> site and not on a local intranet.

Rationale:

The pollbook was held on the District's intranet which limited the places the District could use for Vote Centers. To be networked into the intranet, the Vote Center had to be in a school building. Many District voters live south of 57th Street in Lincoln County, but the District does not have any schools south of 57th Street. In the past, the District has had two to four polling places in Lincoln County.

If the pollbook was held on a secured, encrypted internet site, the Vote Centers could be operated where people congregate. There is the potential to have a vote center in the mall, a hospital lobby, a public building downtown, or in the city-operated community centers, as well as school buildings, thereby, potentially increasing voter turnout.

More pollbook licenses will be needed for a larger election in Sioux Falls.

More pollbooks and possibly up to five more Vote Centers would be needed for a larger local (mayoral) election in Sioux Falls.

If counties chose to use vote centers, there could be numerous vote centers in the main city of the county and one in each of the towns where polling places are normally used. In Minnehaha County, for instance, Sioux Falls could have 15 vote centers, and then only one polling place at Brandon, Hartford, Humboldt, Garretson, Valley Springs, etc. Minnehaha could potentially go from 74 polling places to 26, saving time and money. The ballot receipt would become important at that time to make sure voters receive the correct ballot, due to different legislative districts. The best part of using Vote Centers is that no voter is sent away to a different location. They may vote at any Center.

Overall, the Vote Centers and electronic pollbooks are efficient tools for election supervisors to use. Using these tools saves time for jurisdictions and saves taxpayer dollars. In the Sioux Falls School District, every dollar saved and not budgeted towards elections could be redirected to be used in the classroom, which is its primary mission: "to educate and prepare each student to succeed in a changing world."





S.F. set to test new voting ways

Process gets scrutiny in school board election

By Josh Verges


The voting process will be watched as closely as the vote counts in Tuesday's election for Sloux Falls School Board.

It will be South Dakota's first stiempt at electronic polibooks and voting cen-ters, which will allow school district residents to vote at any of 10 schools throughout the district, no matter where in the city they live.

Secretary of State Jason Cent was a state sensior in 2009 when the school district's election man-ager, Bev Chase, asked him to sponsor logislation to make

the experimental election possible. After a skeptical then-Secretary Chris Nelson succeeded in making changes, the bill passed almost unanimously.

Gant will be in Sigux Falls on Tuesday to keep an eve on



new system's pros plans to present another bill next session that would make electronic polibooks an option for more ctions across the state.

"Any time we can make elections more efficient and make it easier to vote, (1 am) very interested," he said.

"We'll definitely have legislation come 2012."

Chase said the technology holds great promise if used in conjunction with voting centers, especially for rural counties. It would mostly solve the problem of people trying to vote at the wrong politing place and give them more options for where to fill out a bailot.

Scanning your ID

The process works like this: Voters will check in at the polls with an election worker who will use one of the electronic polibooks to pull un their voter information. The worker will scan a driver's license or other official identification card or can key in the voter's name. The voter also signs a keypad similar to those at the grocery store when using a credit card to pay.

When the polibook verifies that the voter is eligible, the voter gets a receipt. That receipt is turned in for a paper ballet, which is filled out like those in previous elections.

The automation of the check-in process allows poll workers to find any of the 96,000 registered voters in the district, making it possible for them to vote at any poling place, Chase said, it also eliminates the use of the large bound volumes full of names and prevents repeat voting.

Election workers also will have a system in place

in case a voter's information is not in the system so that those voters will get to vote on the spot, Chase said.

Gant has apent about \$30,000 on hardware and software for Tuesday's election, from driver's license scanners and electronic signature pada to ballot receipt printers. He plans to make that equipment available to more goverament bodies who want to try it am for their elections.

Rapid City interest

Pennington County elections supervisor Lori Severson is among those taking an interest in the Sloux Falls election. Although reducing the number of polling places could be a burden for some rural residents, she sees voting centers as a money saver.

"Hopefully, it'll be the thing of the future," Severson said. "We discuss voting centers probably every election. It would be a more efficient way to conduct an election.

For Chase, the goal is say. ing money and improving voter participation. The district will spend about \$8,000

paying 74 election workers for the 10 voting centers and \$4,500 to train workers.

The 2009 election, which used 23 super-precincis, cost \$18,000 and set a new low for voter turnout at 3.55 percent of registered voters. Before superprecincts, the district had 59 polling places, all of which needed to be staffed with election workers.

In Debbie Hoffman and Doug Morrison, Sioux Falls. voters will pick from two board-experienced candidates who are getting along and have committed to spending nomoney on campaigns. Incumbent Hoffman is being challenged by Morrison, who previously served on the board.

As such, Chase is counting on the novelty of voting centers to drive turnout,

If 9 percent of registered voters fill out a ballot this time, Chase will consider the experiment a rousing SUCCESS.

"I know that sounds really bad, but for a school election that's protty dang good," she said.







Bright spots to be found despite poor voter turnout

Use of electronic poll books, voting center structure might hint at greater participation in future elections

A 4.2 percent voter turnout in Tuesday's school board election isn't worth cheering, but at least it's better than the city's previous performance.

28

In 2009, the school board contest was the only race on the ballot, and 3.55 percent of registered voters turned out then.

The use of 10 voting centers and electronic poll books helped bure more people to the pulls this year. And the experiment's success shows that state officials should make way for more cities to use the method.

Sinux Falls School District officials had sought legislative changes to make voting centers possible this year. Without that approval, the district's only alternative to belp boost voter turnout would've been to use superprecincts again.

However, superpreclacts confused many voters and haven't shown any real success in improving participation.

Under that format, 57 polling places were reduced to 19 superprecincts. The city's best showing using superprecincts was 2007, which had a 10.19 percent voter turnout.

However, the 2007 election also featured the highly debated

voting centers appear to make the most sense for municipal elections.

Because of electronic poli books, residents could vote at any of the 10 sites they picked, providing greater flexibility. Plus, the system saved money because of the condensed number of locations.

Though only about \$,000 people voted Tuesday, the turnaut was enough to gauge how wall voting centers perform. Based on the success, state officials should consider whatever legislation accessary to expand the centers' use statewide.
