# 1. INTRODUCTION

On the morning of 7 May 2008 the Italian fishing vessel Diomede II entered the port of Giardini di Naxos escorted by two Greenpeace inflatables. Port Authority military personnel were waiting for it. The fishing vessel had been intercepted by the activists 27 miles off Capo Spartivento – it had been using illegal driftnets to catch prohibited species outside the authorised fishing area. An onboard inspection led to the seizure of about 3km of nets and 11 tunas. In the ‘sea’ of illegality in which the Italian driftnets fishery is floundering, this case would have attracted little interest were it not for the fact that in January 2009 it was brought before the United States Congress by the National Marine Fisheries Service of NOAA (National Oceanic and Atmospheric Administration) for illegal, unreported and unregulated (IUU) fishing activities. NOAA’s report defined the Diomede II’s fishing activity as being in violation of ICCAT’s<sup>1</sup> Recommendation 03-04, which prohibits the use of driftnets to capture large pelagic species in the Mediterranean Sea. Together with other illegal fishing activities where Italian vessels used spotter planes to track down bluefin tuna schools, this case earned Italy a place on NOAA’s blacklist of States that practise IUU fishing, which brings with it a risk of future commercial sanctions by the USA<sup>2</sup>.

IUU fishing is one of the most serious threats to marine living resources and threatens the very foundation of the Common Fisheries Policy (CFP) and other fisheries management systems. The value of IUU fishing globally has been estimated at more than €10 billion<sup>3</sup>.

The lack of controls and the absence of effective sanctions in several Member States make European waters particularly vulnerable to illegal fishing. According to a recent study<sup>4</sup>, a successful fight against IUU fishing could create 27,000 new jobs and catches worth €10 billion in Europe by 2020. If Italy fought seriously against the IUU fishing of bluefin tuna and swordfish alone, the value of annual catches would increase by about €26 million and would lead to the creation of 1,000 jobs in the fishing sector by 2020.

To counter the violations, the European Union (EU) approved a new set of rules on IUU fishing, which came into force on 1 January 2010<sup>5</sup>. Regulation 1005/2008 provides a harmonised system of proportionate and deterrent sanctions; extends the responsibility to abide by CFP rules to EU citizens, who can be prosecuted in their countries for violations committed in any part of the world; and closes access to the European market for marine fishery products coming from illegal activities. Moreover, the Regulation authorised the Commission to draw up two blacklists: the first includes vessels engaged in IUU fishing; the second lists States that turn a blind eye to illegal fishing activities.

## 2. ITALIAN IUU FISHING ACTIVITIES

Every year, with the onset of the swordfish season, we see one of the greatest problems within Italian fisheries occur once more – the widespread use of illegal driftnets (*spadare*<sup>6</sup>, and *ferrettare*<sup>7</sup> that are used illegally). This practice has been well-documented over the years by the control authorities, the European Commission and environmental groups, and this accumulated information gives us a clear idea of the extent of the problem. Even so, the problem is not diminishing and those who have the responsibility, and the means, to act do not always do so.

An analysis carried out by the Italian General Command of the Corps of Port Captaincies – Coast Guard (CCCP)<sup>8</sup> reveals much information about the driftnetters: fishing permits; port of registration; access to public funds; recidivism in infringements; fishing areas; and systems to evade controls.

Equally well-known, however, are the loopholes in the national sanctions system that stop the CCCP intensifying the repressive measures. The situation is further compounded by the tolerant attitude, sometimes bordering on complacency, which often occurs towards those who act outside the rules.

Annex 1 of this report lists the vessels sanctioned by the port authorities in the last six years for their illegal use of driftnets, as well as others reported by environmental groups. There are about 300 units, mainly fishing vessels but also some supply ships. Many of these vessels have been sanctioned more than once, sometimes in the space of a few days.

The maximum administrative penalty is only €6,000 – and those who negotiate often pay only one-third of the fine, sometimes even less. The preventative seizure of illegal nets is another penalty, however, this is not always upheld by the judicial authorities and the nets are returned to their owners.

Once again, the case of the *Diomede II* is significant. On 9 October 2008 a tribunal agreed to return the nets to their owner, Vito Spina, on payment of a €1,548 fine<sup>9</sup>.

Such a sanction can hardly be considered a deterrent. Stronger sanctions are needed, such as a suspension of the fishing permit, which is provided for in Article 3 of the Ministerial Decree of 14 October 1998 entitled 'Technical use of the gear named *ferrettara*'<sup>10</sup>:

*"The violation of the provisions as to the previous articles is sanctioned with the revocation of the permission to use the ferrettara, for a period of three months for the first infringement, or for a period of six months in cases of subsequent infringements."*

But this rule has never been applied to the *Diomede II* nor to other vessels sanctioned for illegal use of the *ferrettare*. This was documented in an investigation by the daily newspaper *Il Fatto Quotidiano*<sup>11</sup> on 8 July 2010 and two European Commission Communications on the violations of the European CFP, which together show that between 2005 and 2006 Italy did not suspend a single fishing permit<sup>12</sup>.

### 3. THE TOLERANT PORTS

---

Fishing vessels that use illegal driftnets are concentrated in central and southern Italy, mainly in the ports of Bagnara Calabria, Ponza, Lipari, Porticello and Santa Maria La Scala. These ports give shelter to over one-third of the pirate fleets.

Their presence is largely tolerated by the local authorities, who are often well-disposed towards them, especially during the swordfish fishing season when the illegal nets are fully operative. In June 2010 the municipality of Acitrezza even organised the Festival of San Giovanni Swordfish, which celebrated fish caught with the “historical *spadare*<sup>13</sup>” – that is, the type of nets that were banned first by the United Nations then by the EU.

In Bagnara, also in June 2010, the voluntary delivery/handover of *spadare* was conducted in the presence of the Mayor, Cesare Zappia; the Commander of the Marine Directorate of Reggio Calabria, Vincenzo de Luca; regional councillor Santi Zappalà; and representatives of two fishing industry organisations, Legapesca and Federpesca. Also present was the local councillor for environmental policies, Vincenzo Bagnato<sup>14</sup>, a leading figure in Bagnara whose family owns several fishing vessels that fish with *spadare*. According to the RAI 3 television programme Report, one night in June 2008 Councillor Bagnato was recognised as he was landing with a vessel, the *Lupo di Mare II*, which was full of driftnets<sup>15</sup>.

The owners of several Bagnara vessels (*Angelina*, *Antonella I*, *Carmela Madre*, *Giuseppe Padre*, *Marcantonio IV*, *Mistral*, *Nettuno*, *Papà Carmelo*, *Salvatore II*, *Stella del Mare*) handed over about 300km of *spadare* in total; some, in return, received a temporary longlines fishing permit.

It is a shame, therefore, that only a few days after the handover of the illegal nets, the *Antonella I* was found at Terracina with more than 4km of illegal nets, and then at Bagnara on 12 July with another 4km of illegal nets.

The possibility of having a permit for the small coastal driftnet *ferrettara* and one for longlines contemporaneously has provided the crews with an opportunity to declare, in case of inspections, that the swordfish or tuna in question were caught with longlines. To back up their declaration, the crews can manually insert longline hooks into the mouths of the fish before an inspection, making it impossible for investigators to prove that fish have been caught with *ferrettara* rather than longlines. Wounds or amputations in the fish are strong evidence of the use of driftnets but are not sufficient proof for the law.

Assigning fishing permits, even temporarily, for longlines to those who have illegally used the *ferrettara* is a further example of indulgence by the Ministry of Agriculture Policies towards those who fish illegally with driftnets.

## 4. PUBLIC FUNDS FOR IUU FISHING

Following the ban on the use of high-seas driftnets, since 1998 about €97 million have been allocated by the EU and Italy to subsidise the conversion of *spadare* to other fishing gears.

In 2002, to encourage the last users of *spadare* to join the Conversion Plan, the Italian government complemented these funds with the offer of a fishing permit for the *ferrettara*. But something went wrong and many of these subsidised vessels continued to use illegal driftnets.

Research published by fishsubsidy.org<sup>16</sup> has revealed that one-third of the vessels penalised for the use of illegal driftnets between 2005 and 2010 had received €10.5 million from the Conversion Plan, as well as another €3.3 million for modernisation, retirement or dismantling purposes. However, the lack of transparency in the allocation of the European funds makes it difficult to obtain a clear and complete picture of the aid received by individual operators, and the overall amount is probably much higher.

The following vessels were caught using illegal driftnets after receiving subsidies.

- The *Nuova Michelangelo* (7PA1871), penalised twice, in 2006 and 2008, for the illegal use of *ferrettara*, received €262,000 in subsidies, under the Conversion Plan.
- The *Orazio II* (6RC307), caught in 2008 with 11km of *spadare*, received €56,000 under the Conversion Plan and another €66,000 in 2007 for vessel modernisation.
- The *Orazio I* (1MZ1011), caught red-handed twice in one month in 2005, first with *spadara* and then with a non-standard *ferrettara*, received €173,000 for conversion, €17,000 for modernisation and another €101,000 in 2007 for its dismantling.
- The *Verena* (2LI2890), built with an €87,000 subsidy in 2003, was caught in 2006 with *spadara*.
- Although the vessel MZ1026 was recorded as having been demolished in 1999, in 2006 it was caught with *spadara* north of the island of Ustica after having received €217,000 thanks to the Conversion Plan and another €123,000 to be scrapped.

And finally, we look at the *Sibari* and *Sibari II*, which were both registered in Bagnara. In 2002 *Sibari* received €72,000 from the Conversion Plan and an additional €403,000 in 2004 to be dismantled. *Sibari II*, sanctioned three times for the use of illegal driftnets between 2005 and 2006, received €545,000 in subsidies to leave the fleet at the end of 2006.

In June 2008 the European Commission took legal action against Italy, announcing that:

*"Since it was introduced in 1992, the prohibition on retaining on board and using driftnets of a length greater than 2.5 Km and, since 2001, driftnets of any length, has been systematically and massively infringed by the Italian fishing fleet."*

Moreover, the Commission pointed out that the extent and seriousness of this problem are directly attributable to the lack of control and the inadequacy of the sanctions, and that violations:

*"...are not regularly reported by the local surveillance authorities to the competent authorities, principally due to existing social pressures, and are not, in any event, effectively pursued and penalised. The number and range of penalties imposed is, in fact, derisory<sup>17</sup>."*

On 24 July 2008, after a verification of the use of the Conversion Plan funds, the Commission called on the Italian government to return €7,762 million<sup>18</sup>. The procedure was based on the violations reported by Italy to the Commission under Regulation (CE) 1681/94, which regulates irregularities and the recovery of sums wrongly paid through the funding of the European structural policies. To that sum will be added another €7,762 million, bestowed by the Conversion Plan in the form of the national co-financing quota, which the Italian parliament registers as being charged to the Rotation Fund of the Ministry of Finance<sup>19</sup>.

But serious doubts remain about the effective recovery of the contributions received by fishers, despite what was stated in June 2010 by the Minister of Agriculture, Giancarlo Galan, in response to a parliamentary question:

*"We inform you that the control authorities, once they have verified a driftnet fishing activity carried out by fishers who received public funds for the reconversion of the gear, transmit to the competent Public Prosecutor's Offices the expected offence notices, for undue perception of State or European Community contributions, activating the recovery procedures provided by the current legislation."*

A verification by the Italian Court of Auditors could help to dispel the impression that Italian taxpayers have twice assumed this financial burden, first by financing the Conversion Plan and then by refunding the embezzled sums: €31 million in total.

## 5. IUU FISHING COOPERATIVES

---

Vincenzo Bagnato, the councillor for environmental policies in Bagnara Calabra (see above) is, together with his brothers, a member of the La Marinella cooperative that manages at least three fishing vessels, the *Carmela Madre*, the *Don Rocco* and the *Uragano*. The three vessels were sanctioned a total of six times between 2005 and 2008 for the use of *spadare*. In June 2010 the *Carmela Madre* participated in a voluntary handover of *spadare* and received a temporary fishing permit for longlines in exchange. But there is no sign that the nets of the *Uragano*, which already had a longlines fishing permit, were ever returned.

It is to be noted that in 2010 the regional government of Calabria allocated the *La Marinella* cooperative €285,000 for a processing and marketing investment project, under the European Fishery Fund (EFF)<sup>20</sup>.

The *spadara* is a passion shared by various members of the Bagnato family. For example, Giovanni Bagnato is the owner of the *Luna Rossa*, a vessel caught in 2008 with *spadare*. Francesco and Giuseppe Bagnato are the respective owners of the *Lupo di Mare II* and *Squalo*, fishing vessels caught with *spadare* in 2005. Salvatore Bagnato's vessel, *Mistral*, was detained with a *spadara* in 2006.

Finally, the *Don Rocco*, owned by the Bagnato family, was caught off the coast of MARETTIMO with illegal driftnets in August 2008.

In Lipari, the cooperative *La Primavera* has five fishing vessels: *Agostino*, *Daniela*, *Marino*, *Raffaello*, and *S.Bartolo di Minnicuzzu*. These vessels have been sanctioned 12 times altogether for illegal use of *ferrettare*. All five vessels have a longlines fishing permit.

The *SS.Salvatore*, a fishing cooperative in Cefalù, owned five vessels. The *S. Giuseppe*, *Delfino*, *S. Antonio* and *Jessica* were sanctioned between 2007 and 2009 for the illegal use of *ferrettare*. The fifth vessel, the *S. Lucia*, was caught with a *spadara* in 2008 and left the fleet the following year.

Three out of the four vessels owned by the fishers cooperative *S. Giovanni Bosco* in S. Agata di Militello (*Aurora*, *Emilia* and *Nicola Padre*) were sanctioned for the illegal use of *ferrettare*; the fourth vessel, the *Francesca Madre*, was caught with a *spadara*.

These are just a few examples of how it is not only individual operators who are involved in IUU fishing for swordfish and bluefin tuna – fishers cooperatives are also fully involved.

## 6. THE ROLE OF THE EUROPEAN UNION IN COMBATING IUU FISHING

---

IUU fishing contributes to the overexploitation of fish stocks, damages marine ecosystems, creates unfair competition for honest fishers, causes loss of income from this sector and puts at risk the survival of coastal communities in developing countries. For these reasons, the enforcement of new sanctions adopted by the EU for European citizens and fishing vessels involved in IUU fishing could be a serious deterrent to illegal fishing activity – and a strong signal to third countries that suffer from the incursion of European vessels into their waters in violation of local management rules. The credibility of the Community action would surely be reinforced if, at the same time as the European market is closed to illegal fish products coming from non-EU countries, a correspondingly strong action is taken against European illegal fishing.

On 1 January 2010 Regulation 1224/2009, which establishes a system of controls to ensure the observance of the CFP rules, came into force and constitutes an integral part of the Commission's strategy to combat IUU fishing.

This control Regulation and the IUU Regulation 1005/2008 share the same objectives and have a complementary function in their application to EU citizens and fishing vessels. But while the IUU Regulation has been fully effective since the beginning of January 2010, the control Regulation will be phased in gradually and will not be fully implemented until 2014.

Under Regulation 1005/2008 a vessel is considered to be engaged in IUU fishing if it has:

- fished without a valid licence, authorisation or permit;
- not fulfilled its obligations to record and report catch-related data, including data to be transmitted by satellite vessel monitoring system;
- fished in a closed area, either without a quota or after its quota has been exhausted;
- fished directly on a stock for which the fishery has been suspended or prohibited;
- used prohibited or non-compliant fishing gear;
- falsified or concealed its identity;
- concealed, tampered with or disposed of evidence relating to an investigation;
- obstructed the work of inspectors;
- taken onboard, transshipped or landed undersized fish in contravention of the legislation in force;
- transshipped, participated in joint fishing operations with supported, or re-supplied other fishing vessels identified as having engaged in IUU fishing under this Regulation;
- carried out fishing activities in the area of a regional fisheries organisation in a manner inconsistent with or in contravention of the conservation and management measures of that organisation.

These activities are to be considered serious infringements, the level depending on the seriousness of the infraction committed, and this will be determined by the Member State on the basis of criteria such as the damage caused, its value, the extent of the infraction or its recurrence.

The seriousness of the infractions committed by vessels using illegal driftnets cannot be denied, considering that this kind of fishing:

- a) aims to capture unauthorised species;
- b) is practised with prohibited or non-compliant fishing gears;
- c) does not report or record catch-related data;
- d) is often carried out in unauthorised areas;
- e) often does not transmit data through the satellite vessel monitoring system;
- f) causes serious damage to stocks that are already heavily overexploited, catching specimens outside of any management measures;
- g) puts at a serious competitive disadvantage the honest fishers who have to observe rigorously the fishing limits assigned by the EU;
- h) is a form of dumping that could put on the market products of high commercial value at competitive prices, without taxes having been paid;
- i) records a very high rate of recidivism: it is not a question of occasional infractions; this is a well-structured and deeply-rooted illegal fishing system that recurs every year with increasingly sophisticated techniques and that enjoys considerable bargaining power with the local authorities and the Ministry for Agriculture Policies.

Therefore, the fishing vessels and operators engaged in these illegal activities must be subjected to the sanctions provided for in the IUU Regulation and to those of the Regulation on controls that are already in force. Sanctions that could be particularly dissuasive would include insertion of the vessel on the Community's IUU vessel list, resulting in:

- the withdrawal of the fishing authorisation or licence in Community waters;
- being prohibited from landing in other ports other than the home port, apart from in an emergency;
- being prohibited from marketing its own products in the European Community;
- the obligation of the Member State not to grant any national or Community public funds to operators associated with its use, management or ownership.

This last measure does not apply if a Member State has applied effective and dissuasive sanctions, something which, as shown above and as demonstrated by the frequent cases of recidivism listed in Table 1, the Italian government has never done.

Also, Article 43 of the IUU Regulation imposes on the Member State the obligation to take immediate measures, such as the confiscation of fishing gears and the suspension of the fishing authorisation, when operators are caught breaking the fishing rules. It remains to be seen if the Italian government has observed the above obligations in the case of IUU fishing with driftnets sanctioned in 2010.

Finally, the Regulations have introduced two important changes. The first concerns the authority granted to the European Commission to intervene with corrective measures if a Member State reveals itself to have defaulted in or to be incapable of fulfilling its responsibilities in punishing the illegal operators, so that they do not profit from their activities. In these cases the Commission can act to obtain information on the illegal activities and can ask the Member State to start an investigation and take all the necessary measures. Moreover, the Commission can carry out independent inspections and audits on the efficacy of the national sanctions system.

Secondly, the Control Regulation introduces the possibility for the Commission to suspend financial assistance destined for the fishing sector in the case of a Member State which does not adopt corrective measures to guarantee full compliance with and application of the CFP rules.

## 7. CONCLUSIONS

---

Unlike the past eight years, during which time the EU has not been able to combat effectively the widespread use of illegal driftnets, today there are tools that allow the European Commission to intervene more quickly and certainly more effectively than through the infraction procedures.

The evaluation of the political opportunity to intervene or not with a Member State by applying strongly deterrent measures should not, however, prevail over what is objectively a crisis situation for the stocks of bluefin tuna in the Mediterranean Sea, a situation made worse by illegal driftnet fishing.

Nor can Europe continue to tolerate a serious and persistent situation of illegality that, besides being condemned by public opinion, puts one of its Member States in a situation where it faces eventual commercial sanctions by the US administration.

At risk is the credibility of the actions taken by the EU against IUU fishing both in the ambit of regional fisheries management organisations and towards those third countries of which Europe, in return for access to the European market, asks more severe controls, more effective sanctions and certification of fisheries products. Moreover, it is in the interest of the sound part of the sector to ensure that those who violate the rules are excluded from fishing activities. For example, producers' organisations and fisheries groups should expel those members who have repeatedly broken the CFP rules.

The Mediterranean represents an important testing ground for the EU's strategy on IUU fishing. On the eve of the revision process of the CFP, it is time to avoid repeating past mistakes; today there are not only the tools to impede IUU fishing but also a wealth of past experience. Only through strong action can illegal driftnets be eradicated and the concrete commitment of the EU to combat IUU fishing be demonstrated to the operators and to the European public. The restoration of legality in fishing is not only an absolutely necessary condition for the recovery of marine ecosystems but also an essential element for the development of a truly sustainable fishing industry.
