



The Pew Charitable Trusts – Marine Life Survey

Topline Report • April 9, 2021

The survey was conducted for the Pew Charitable Trusts by SSRS, an independent research company, through the SSRS Panel and ABS. Interviews were conducted from February 11 – March 10, 2021 among a representative sample of 1,847 total respondents. The margin of error with design effect for the total respondents is +/-3.26% at the 95% confidence level.

The North Atlantic right whale mainly lives along the east coast of the U.S. and Canada. They are migratory and are found in different areas of the ocean at different times of the year. They are considered "critically endangered." However, there is disagreement on how—if at all—they should be protected, and at what cost to fishermen and consumers.

One of the leading causes of death among North Atlantic right whales is getting caught in the ropes of lobster fishing gear, particularly in areas where whales gather. Proposals to protect right whales from getting caught in these ropes involve controlling: (1) the type of lobster fishing gear used and/or (2) when and where lobster fishermen can operate. However, some believe such rules would hurt consumers and small businesses more than they would benefit whales.
