AJA Behavioral Health Screening and Assessments in Jail Survey Methodology and Toplines

This survey was designed and analyzed by public opinion researchers at The Pew Charitable Trusts in collaboration with the American Jail Association (AJA) and was conducted from May 21, 2023, to Feb. 28, 2024. The purpose was to better understand the extent to which jails can identify people with mental health and substance use issues. To do so, the survey was disseminated to U.S. jail administrators through the AJA via Qualtrics. There are more than 3,116 local jails in the United States, plus an additional 80 jails located on Native American reservations and operated by tribal authorities or the Bureau of Indian Affairs. The Pew survey received responses from 100 facilities, approximately 3% of jails. The sample size does not lend itself to broad determinations about jails and behavioral health assessments but it does provide an important snapshot of how these tools may be deployed and can give jail administrators a glimpse into how other administrators throughout the country are managing screenings and assessments and how to best use them.

In total, 1,441 individuals were invited using email addresses obtained from the AJA. The survey was selfadministered in Qualtrics; because of the nature of the questions, links to the survey were potentially forwarded to other personnel to answer the survey. Because of issues with the email lists, such as staff turnover and email bounce backs, researchers looked for additional personnel or email addresses of those who could take the survey. The data was cleaned to remove incomplete responses (those with 50% or fewer questions answered), and the final sample size is 100 people.

This survey was sent to all AJA jail administrators and was not weighted. Because this population may not be all jails in the United States and because of the low response rate, results cannot be generalized. All forms of survey research are subject to unmeasured error that cannot be eliminated, including coverage error, sampling error, nonresponse error, measurement error, and data processing and editing error. Incentives were not offered to respondents for completion of the survey.

SCREENING AND ASSESSMENT FOR MENTAL HEALTH ISSUES

Now, we would like to discuss if and how your jail identifies mental health issues.

Throughout this survey, we use **"screening"** to mean a brief, routine process to identify indicators - "flags" - for the presence of mental health and/or substance use issues that reflect an individual's need for treatment and/or an alternative setting or situation. Screening may include a brief interview, use of self-report instruments, or a review of prior records.

We use **"assessment"** to indicate a clinical interview that may include psychological, laboratory, or other testing. Assessments are usually conducted by a trained professional who is either licensed or certified to provide mental health and substance use treatment services.
