
JAPAN

Clean energy investment in Japan increased a modest 10 percent to \$3.3 billion in 2010, placing it 11th among G-20 members. Japan's five-year growth rate in clean energy investments ranks last in the G-20. Japan's clean energy sector is dominated by solar, which received 96 percent of the nation's clean energy investments. Japan has almost 20 gigawatts of installed biomass energy, and its steady adoption of solar energy has resulted in 3.5 GW of installed capacity. Japan has set ambitious targets to source 28 GW from solar and 5 GW from wind by 2020. Active pursuit of these goals would make it one of the G-20's most promising growth markets.
