RE: America's Small Businesses Need Protection from CAFO Pollution

Dear President Obama:

On behalf of the more than 150 undersigned businesses, we write to urge your immediate action on an issue that threatens small businesses across the country: pollution from concentrated animal feeding operations (CAFOs).

As a candidate for president and during the transition, you promised to control pollution from industrial livestock operations. Now, four and a half years later, information on CAFO locations and manure generation has not been assembled, CAFO pollution in many communities is inadequately controlled, and many CAFOs operate without permits under the Clean Water Act (CWA). This is of significant concern for small businesses that rely on clean water for their survival. Your administration has said that small businesses are the engines of job creation and essential to strengthening our national economy. Therefore, we urge you to follow through on your promise to strengthen the permitting requirements for CAFOs and regulate them as the industrial operations they are.

According to a report prepared by state and federal regulators, U.S. livestock facilities generate on the order of one billion tons of manure every year. That waste can cause pollution in the form of runoff into streams, lakes and bays – causing fish kills and beach closures, creating dead zones and algal blooms, interfering with drinking water treatment systems, and risking public health. Ultimately, small-business owners who rely on activity in or around those bodies of water can be left struggling to meet their bottom line.

CAFOs are one of the greatest uncontrolled sources of pollution to some of our nation's most prized waterways. Without stronger, more comprehensive regulations, CAFO pollution will continue to pose a threat to small businesses like ours that rely on clean water. Therefore we urge you to direct the EPA to strengthen permit regulations for CAFOs under the Clean Water Act, to ensure that public health, the environment, and small businesses across the United States are protected.

Thank you for considering our views and your commitment to support small businesses.
